- 1) **18" Amoeba Combined Test:** Dressage Test - 2011 USDF Intro Test A. *Max. Obstacle height is 18".
- 2) **2' Tadpole Combined Test:** Dressage Test - 2011 USDF Intro Test B. *Max. Obstacle height is 2'.
- 3) **2'7" Beginner Novice Combined Test:** Dressage Test - 2010 USEF Beginner Novice Eventing Test B.
*Max. Obstacle fixed height is 2'7".
- 4) **2'11" Novice Combined Test:** Dressage Test – 2010 USEF Novice Eventing Test B.
*Max. Obstacle fixed height is 2'11".
- 5) **3'3" Training Combined Test:** Dressage Test - 2010 USEF Training Eventing Test B.
*Max. Obstacle fixed height is 3'3".

Rules

(1) An ASTM-SEI helmet required when mounted. (2) No muckers, chaps, or jeans permitted. Jackets not required. (3) Safety vests not required but encouraged. (4) All tack must be in compliance with USEA Combined Training rules. (5) All Dressage tests must be ridden in bits with no copper. (6) Martingales, bit guards, gadgets, boots and bandages not permitted during Dressage tests. (7) ALL riders must wear a USEA or USPC medical armband, on the upper left arm, during the competition. ***No dogs on show grounds, please.***

There will also be shade tents and water adjacent to dressage arenas and jump field. **A first place prize plus six ribbons** will be awarded in each CT class. **First through third place ribbons** will be awarded in each dressage-only class. In addition, there will be a Best Dressage Score Award for Junior (18 and under) and Senior riders. Also, a perpetual trophy, donated by Jimmy Smith Jewelers, will again be awarded to the Pony Clubber with the Best Combined Training Test Score. A perpetual trophy will be awarded to the rider with the Best Combined Training Test Score. **Schooling Cross-Country** will be permitted at the end of cross-country competition at \$25 per horse/rider as time allows. In Consideration for the privilege of riding and working around horses at the **Huntsville Pony Club Cross-Country field at Wolfgap Farm** the undersigned does hereby agree to hold harmless and indemnify the **United States Pony Clubs, Inc, Midsouth Region, Huntsville Pony Club, Tim and Barbara Fisk, Wolfgap Farm**, its officers, sponsors and members and further release them from any liability or responsibility for accident, damage, injury or illness to Undersigned or any horse owned by me or to any family member or spectator accompanying the Undersigned on the premises of Wolfgap Farm.

I fully understand that cross-country riding is a very dangerous activity. I fully understand that riding is a very dangerous activity with many inherent risks including (i) The propensity of an equine to behave in dangerous ways which may result in injury to the rider, trainer, groom or handler, (ii) The inability to predict an equine's reaction to sound, movements, objects, persons or animals. I wish to participate in these activities knowing they are dangerous. I accept and assume all the risks of injury (including death) to me or to my property.

In exchange for being permitted to participate in these activities for heirs, my guardian, legal representatives, and myself I release and agree not to make or bring any claim of any kind against the United States Pony Clubs, Inc., MidSouth Region, Huntsville Pony Club, Wolfgap Farm, Tim and Barbara Fisk, their employees, or guests or any landowners, landholders or the persons making property available for equine activities for injury (including death), to me or any damage to my property whether from anyone's negligence or not, or any other cause, arising out of my participation in these dangerous horseback riding or related activities; and I also agree if anyone makes any claims because of any injury to me (including death), or for any damage to my property, I will keep all those released by this agreement free of any damages or costs because of those claims. Directions to Huntsville Pony Club Combined Test at Wolf Gap Farm

From North: Going south on I-65, take exit 14 (US Route 64) off I-65 and turn right. Go 4/10 to 5/10 of a mile, and turn left. Go 1.5 miles and bear left under interstate. Immediately after passing under interstate, bear right. Now go 2.5 miles and turn right onto Tarpley Shop Road at stop sign. Bear to the left after about a third of a mile. Two more miles and you are at the show entrance.

From South: Going north on I-65, take Tennessee exit 6 off I-65 and turn right. Go 4.75 miles to stop sign and turn left onto Tarpley Shop Road. Bear to the left after about a third of a mile. Two more miles and you are at the show entrance.

From Show Grounds: Turn right out of parking area. Go one mile, then turn left on Hardy Road.

For Paddocks: Go one mile and turn left into entrance "Tick Ridge". Paddocks are ahead on the right.

For Stalls: Remain on Hardy Road for another 1/2 mile. Turn right at signs.
